

**RESOLUTION NO. 2011- 122**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, DEDICATING THE NEWLY CONSTRUCTED NASSAU COUNTY FIRE RESCUE STATION 60 IN NASSAU COUNTY, FLORIDA**

**WHEREAS**, groundbreaking for the Bryceville Volunteer Fire Department in Bryceville, Florida, was held on February 2, 1974; and

**WHEREAS**, this fire station was the first fire station to serve the Bryceville community; and

**WHEREAS**, volunteers of this fire station built the 3,700 square foot building using 2,200 manhours; and

**WHEREAS**, a dedication ceremony was held on November 2, 1974 at which former Representative George Grosse was present and was quoted as saying "this building stands as a monument to the people of the Bryceville community"; and

**WHEREAS**, upon completion, this original building housed 32 volunteer staff who were dedicated to serve and protect the citizens of the Bryceville community; and

**WHEREAS**, Nassau County Fire Rescue paid personnel assumed the operations of Station 60 on December 1, 1992 and occupied the Bryceville Volunteer Fire Department in order to continue to serve and protect the citizens of the Bryceville community; and

**WHEREAS**, due to growth in the area, the Board of County Commissioners of Nassau County, Florida has built a fire station that shall replace the former Fire Station 60 with a newly constructed fire station; and

**WHEREAS**, the newly constructed fire station shall be known as Nassau County Fire Rescue Station 60; and

**WHEREAS**, Nassau County Fire Rescue Station 60 is located in County Commission District 4; and

**WHEREAS**, on September 10, 2011, the Board of County Commissioners of Nassau County, Florida, will formally dedicate this new fire station that has been constructed in the northeast quadrant of US 301 and Motes Road intersection in Bryceville, Florida; and

**WHEREAS**, Nassau County Fire Rescue Station 60 will serve and protect the lives and property of the citizens who reside in Bryceville, Florida.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Nassau County, Florida that:


