## **RESOLUTION NO. 2011-86**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, VACATING, ABANDONING AND DISCONTINUING OF ANY RIGHT OR INTEREST OF SAID NASSAU COUNTY, FLORIDA, AND THE PUBLIC IN THE PLAT KNOWN AS HERON POINTE, OR A PORTION THEREOF, AS RECORDED IN PLAT BOOK 7, PAGES 216 AND 217, OF THE PUBLIC RECORDS OF NASSAU COUNTY, FLORIDA.

WHEREAS, the petition of Michael S. Mullin, requesting that the Board of County Commissioners of Nassau County, Florida, vacate a portion of the plat described below, and renounce and disclaim any rights of the County and the public in and to the plat and any lands in connection therewith, in accordance with Chapter 177, Florida Statutes, was duly presented to the Board at a regular meeting held on May 9, 2011; and

WHEREAS, the Petitioner is fee simple title holder to the underlying land sought to be vacated in accordance with Chapter 177, Florida Statutes; and

WHEREAS, a notice of intention to apply to the Board of County Commissioners to vacate the plat was duly published in the Fernandina Beach News Leader, a newspaper of general circulation in Nassau County, Florida, on June 1, 2011 and June 8, 2011; and

BEING THAT PART OF SECTION 11 LYING BETWEEN THE NORTH LINES OF TRACTS "A", "B", AND "Q" OF THE GORDIE SUBDIVISION [UNRECORDED] AND THE EDGE OF MARSH AND THE CENTERLINE OF A 20 FOOT WIDE DITCH; BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR A POINT OF REFERENCE COMMENCE AT A 4"X4" CONCRETE MONUMENT FOUND AT THE SOUTHEASTERLY CORNER OF LOT 1, HERON POINTE, ACCORDING TO PLAT THEREOF RECORDED IN PLAT BOOK 7, PAGES 216 AND 217 OF THE PUBLIC RECORDS OF SAID COUNTY; THENCE NORTH 10°56'57" WEST, ALONG THE EASTERLY PLAT LINE OF SAID HERON POINTE, 150.05 FEET TO A FOUND 4"X4" CONCRETE MONUMENT AND THE POINT OF BEGINNING.

FROM THE POINT OF BEGINNING THUS DESCRIBED. THENCE NORTH 10°56'57" WEST, 49 FEET, MORE OR LESS, TO THE APPROXIMATE CENTERLINE OF A 20-FOOT WIDE DITCH, SAID POINT BEING REFERENCE POINT "A" FOR THIS DESCRIPTION; THENCE RETURN TO THE POINT OF BEGINNING AND RUN SOUTH 79°01'09" WEST, ALONG A LINE PARALLEL TO AND 282,60 FEET NORTHERLY OF THE SOUTHERLY LINE OF SAID SECTION 11, 520 FEET, MORE OR LESS, TO ITS INTERSECTION WITH THE APPROXIMATE EDGE OF MARSH; THENCE NORTHEASTERLY, ALONG SAID EDGE OF MARSH, 310 FEET, MORE OR LESS, TO THE INTERSECTION OF SAID EDGE OF MARSH WITH THE APPROXIMATE CENTERLINE OF THE AFOREMENTIONED 20-FOOT WIDE DITCH: THENCE SOUTHEASTERLY, ALONG SAID APPROXIMATE CENTERLINE OF DITCH, 260 FEET, MORE OR LESS, TO REFERENCE POINT "A", AFOREMENTIONED, AND THE CLOSE OF THIS DESCRIPTION.


