RESOLUTION 2014-101

WHEREAS, Nassau County has acquired rights in certain real property which property is utilized for a public roadway;

WHEREAS, the public roadway provides benefits to the citizens of Nassau County, as well as to the general public; and

WHEREAS, the Board of County Commissioners wishes to explicitly accept ownership and dedication of said public roadway.

NOW THEREFORE, BE IT RESOLVED this the <u>16th</u> day of <u>July</u>, 2014, by the Board of County Commissioners of Nassau County, Florida, the real property which occupies and lies within the boundaries described in Exhibit "A" attached hereto (hereinafter "Subject Property"), the roadway lying on said property being known as Christian Way, is hereby dedicated to the public for the purposes and use as a public county road, and that the County hereby accepts said dedication.

FURTHER RESOLVED, that the Subject Property is:

- The same property deeded to the Board of County Commissioners of Nassau County for and on behalf of the public at large via Right of Way Quitclaim Deed from Rayland Company, Inc. dated March 9, 1992 and recorded in Official Book 655, Page 1308, Nassau County Public Records. This being the northerly section of Christian Way.
- The same property described as a 100' non-exclusive easement for ingress and egress as set forth in Official Records Book 963, Page 1080, Nassau County Public Records. This being the center section of Christian Way.
- The same property given by Quitclaim Deed from LFW RESERVE, LLC., a Georgia Limited liability company to The Board of County Commissioners of Nassau County, Florida dated <u>July 24, 2014</u> and recorded in Official Record Book <u>1929</u>, Page <u>264</u>. This being the southerly section of Christian Way.
