Resolution 2014 –023

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, RELATING TO PROHIBITING THRU TRUCKS ON BEAR RUN ROAD FROM BISMARK ROAD SOUTH AND SPRING LAKE DRIVE FROM BEAR RUN ROAD TO LEM TURNER ROAD; PROVIDING FOR FINDINGS BY THE BOARD OF COUNTY COMMISSIONERS; PROVIDING FOR PLACEMENT OF "NO THRU TRUCKS" SIGNS; PROVIDING FOR PENALTIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 316, Florida Statutes, the Florida Uniform Traffic Law, Section 316.006, Jurisdiction, subsection 316.006(3), Counties, provides that Nassau County has original jurisdiction over all its streets and highways located within its boundaries, except all state roads and municipal streets and highways, and may place and maintain such traffic control devices which conform to the specifications of the Florida Department of Transportation upon all streets and highways under their original jurisdiction as they shall deem necessary to regulate, warn, or guide traffic; and

WHEREAS, Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law, Section 316.008, Powers of Local Authorities, subsection 316.008 (1)(i), further provides that local authorities may, with respect to streets and highways under their jurisdiction, exercise the police power to prohibit types of vehicles and.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, finds that placement of "NO THRU TRUCKS" signs as hereinafter described shall serve the health, safety, welfare, and convenience of the residents of Nassau County.

NOW, THEREFORE, BE RESOLVED by the Board of County Commissioners of Nassau County, Florida, that:

<u>Section 1.</u> <u>Findings.</u> The Board of County Commissioners has examined the recommendation by the Department of Engineering Services in relation to prohibiting thru trucks on Bear Run Road from Bismark Road South and Spring Lake Drive from Bear Run Road to Lem Turner, and based upon the investigation, hereby determines "NO THRU TRUCKS" signs are necessary.

Section 2. NO THRU TRUCKS signs to be Placed. "NO THRU TRUCKS" signs shall be placed on Bear Run Road from Bismark Road South and Spring Lake Drive from Bear Run Road to Lem Turner.

<u>Section 3.</u> <u>Penalties.</u> Any person found guilty of violating the "NO THRU TRUCKS" restriction established by this Resolution shall be punished according to the provisions of Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law, Section 316.655, Penalties and Chapter 318, Disposition of Traffic Infractions.

Section 4. Effective Date. This resolution shall take effect upon the "NO THRU TRUCKS" signs being installed and shall expire upon the removal of said signs.
