RESOLUTION NO. 2015-121

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA GRANTING A WAIVER, PURSUANT TO NASSAU COUNTY ORDINANCE 99-17, SECTION 15.2.1, TO BRIAN AND MONICA BLAQUIERE.

WHEREAS, Brian and Monica Blaquiere own a parcel of property whose address is 43526 Red Dirt Ridge Trail, Nassau County, Florida; and

WHEREAS, Brian and Monica Blaquiere purchased the property from Red Dirt Ridge, LLC on October 25, 2013, a copy of the Warranty Deed attached as Exhibit "A"; and

WHEREAS, access to the property is pursuant to a Grant of Easement from Red Dirt Ridge, LLC to Brian and Monica Blaquiere; and

WHEREAS, the easement is referred to as Red Dirt Ridge Trail, described as a 60 foot easement for ingress, egress, and utilities; and

WHEREAS, Red Dirt Ridge Trail is a dirt road not dedicated to the public nor owned or maintained by Nassau County; and

WHEREAS, Brian and Monica Blaquiere applied for a building permit for their property, and the county records indicate there have been five (5) building permits issued on Red Dirt Ridge Trail; and

WHEREAS, Nassau County Roadway and Drainage Standard Ordinance No. 99-17, Section 1.2.2 states that a 60' easement can serve up to five (5) dwelling units and additional units will require the approval of the Public Works Director; and

WHEREAS, the Public Works Director did not approve the sixth (6th) dwelling unit; and

WHEREAS, pursuant to Section 15.2.1 of Ordinance 99-17, after a variance is denied by the Public Works Director, an owner can appeal to the Board of County Commissioners for a waiver and the owners have appealed that decision to the Board of County Commissioners.

NOW, THEREFORE, BE IT RESOLVED this 28th day of September, 2015 by the Board of County Commissioners of Nassau County, Florida, that:

- Based on the Blaquiere's presentation and the facts presented, the denial of the building permit would create a hardship and, based on the standards and objectives of Ordinance 99-17, the waiver is hereby approved.
- 2. The condition of the granting of this waiver is the execution, by Brian and Monica Blaquiere, of the Affidavit attached as Exhibit "B".
- The granting of this waiver is specific to the facts and conditions applicable to Brian and Monica Blaquiere only.
- 4. This Resolution, by consent of the Board of County Commissioners of Nassau County, Florida, and Brian and Monica Blaquiere shall be recorded.

- 2. I purchased real property, as described in Exhibit A attached hereto, from Red Dirt Ridge, LLC that is located on Red Dirt Ridge Trail, Nassau County, Florida (the "Property").
- 3. My Property fronts on a 60' easement, known as Red Dirt Ridge Trail and said easement was conveyed by Red Dirt Ridge, LLC to me.
- 4. Nassau County did not construct, inspect nor approve the construction of the easement.
- 5. The easement is not dedicated to the public.
- 6. Nassau County does not maintain the easement nor will it maintain the easement.
- 7. The responsibility for maintenance of the easement rests with me and the other property owners on Red Dirt Ridge Trail and/or Red Dirt Ridge, LLC.
- 8. Emergency response and/or response times may be adversely affected based upon the maintenance of the easement.
- 9. My Property is not in a platted subdivision, and the County cannot make any assertions as to the adequacy of drainage and there is no approved stormwater management plan.
