## **Resolution 2015-132**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, RELATING TO A PARKING RESTRICTION ON BOTH SIDES OF GREGG STREET 440 FEET NORTH OF JULIA STREET SOUTH TO THE INTERSECTION OF LEWIS STREET, AND ON BOTH SIDES OF JULIA STREET FROM THE INTERSECTION WITH OCEAN BOULEVARD EAST TO THE INTERSECTION WITH GREGG STREET, PROVIDING FOR FINDINGS BY THE BOARD OF COUNTY COMMISSIONERS; PROVIDING FOR PLACEMENT OF "NO PARKING" SIGNS; PROVIDING FOR PENALTIES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law, Section 316.006, Jurisdiction, subsection 316.006(3), Counties, provides that Nassau County has original jurisdiction over all its streets and highways located within its boundaries, except all state roads and municipal streets and highways, and may place and maintain such traffic control devices which conform to the specifications of the Florida Department of Transportation upon all streets and highways under their original jurisdiction as they shall deem necessary to regulate, warn, or guide traffic; and

WHEREAS, Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law, Section 316.008, Powers of Local Authorities, subsection 316.008 (1)(a), further provides that local authorities may, with respect to streets and highways under their jurisdiction, exercise the police power to regulate or prohibit stopping, standing, or parking; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida finds that parking alongside the road hereinafter described will create traffic operations hazards; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, further finds that placement of "NO PARKING" signs as hereinafter described shall serve the health, safety, welfare, and convenience of the residents of Nassau County.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Nassau County, Florida, that:

<u>Section 1.</u> <u>Findings.</u> The Board of County Commissioners has examined the recommendation by the Department of Engineering Services in relation to a parking restriction on Gregg Street and Julia Street, and based upon the investigation, hereby determines "NO PARKING" signs are necessary.

Section 2. NO PARKING signs to be placed. "NO PARKING" signs may be placed on both sides of Gregg Street 440 feet north of Julia Street south to the intersection of Lewis Street and on both sides of Julia Street from the intersection with Ocean Boulevard east to the intersection of Gregg Street.

Section 3. <u>Penalties.</u> Any person found guilty of violating the parking restriction established by this Resolution shall be punished according to the provisions<sup>4</sup> of Chapter 316, Florida Statutes, the Florida Uniform Traffic Control Law, Section 316.655, Penalties and Chapter 318, Disposition of Traffic Infractions.

**Section 4.** Effective Date. This resolution shall take effect each on posting of the No Parking Signs.
