RESOLUTION NO. 2015-163

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, ESTABLISHING CIVIL FINES RELATED TO ANIMAL CONTROL; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 828.27, Florida Statutes, provides that the local government may enact ordinances relating to animal control or cruelty; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, has adopted Ordinance No. 2004-58, as amended, which established animal control regulations for the unincorporated areas and the incorporated areas pursuant to interlocal agreement of Nassau County, Florida; and

WHEREAS, pursuant to Ordinance No. 2015-<u>25</u>, and upon the recommendation of the Animal Control Director, and with the consent of the Nassau County Court Judge, the Board of County Commissioners of Nassau County, Florida, hereby adopts a fee schedule for civil fines for contested and uncontested violations of the Nassau County animal control regulations.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau

County, Florida, that the following civil penalties are hereby adopted as follows:
