WHEREAS, the Code Enforcement Board, after a hearing, has recommended the release of the real property identified as Parcel Number 43-2N-27-4643-0012-0000.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, this 8th day of June, 2015, as follows:

- 1. Based on the recommendation of the Nassau County Code Enforcement Board, the Board of County Commissioners approves the Release of Lien as to the real property described as Parcel Number 43-2N-27-4643-0012-0000.
- 2. The Chairman is authorized to execute the attached Release of Lien as to the described parcel.
- All other real and personal property of Bill and Lindy Cox is not released and the Code Enforcement Board Order of January 29, 2004 remains in effect except as to Parcel Number 43-2N-27-4643 -0012-0000.
