

RESOLUTION NO. 2016-101

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
COMMENDING JOHNNY SELDOMRIDGE AND SELDOMRIDGE
BODY SHOP, INC. FOR ALL THEY HAVE DONE FOR NASSAU
COUNTY FIRE RESCUE.**

WHEREAS, hazardous materials spills including biological, chemical and radiological materials pose a serious risk if not promptly and properly responded to by appropriate emergency response staff; and

WHEREAS, hazardous materials spills involving vehicles provide unique challenges to traffic incident clearance and cause major delays in clearing a site; and

WHEREAS, hazardous materials cargo spills are especially dangerous due to the large quantity of materials being transported and possible threats to the health and safety of the public; and

WHEREAS, on March 3, 2016, Nassau County Fire Rescue, members of the Special Hazards Operations Team, and the Jacksonville Fire Rescue Hazmat Team responded to a hazardous materials call involving a semi carrying approximately 6,500 gallons of Anhydrous Ammonia, an extremely toxic and corrosive gas; and

WHEREAS, upon arrival, Nassau County Fire Rescue began assessing the situation and found the semi and trailer to be very unstable and in danger of tipping over; and

WHEREAS, two wreckers from Seldomridge Body Shop, Inc., arrived on scene and the employees offered guidance to Rescue staff on how to stabilize the tanker using large straps and the tanker was lifted and stabilized safely without incident; and


