

**RESOLUTION NO. 2016-35**

**A RESOLUTION OF THE NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, COMMENDING THE WEST NASSAU HIGH SCHOOL CHEERLEADERS ON WINNING THEIR FIRST NATIONAL CHAMPIONSHIP AT THE UNIVERSAL CHEERLEADING ASSOCIATION'S NATIONAL HIGH SCHOOL CHEERLEADING COMPETITION ON SUNDAY, FEBRUARY 7, 2016.**

**WHEREAS**, the Universal Cheerleaders Association was founded in 1974 by Jeff Webb; and

**WHEREAS**, in 1980, the Universal Cheerleaders Association partnered with Varsity All-Star to create the Universal Cheerleaders Association National High School Cheerleading Competition which is held annually at the Walt Disney World Resort in Orlando, Florida; and

**WHEREAS**, Saturday, February 6 through Sunday, February 7, 2016, the 36<sup>th</sup> Annual Universal Cheerleaders Association National High School Cheerleading Event was held and junior high and high school teams from across the nation competed in various categories; and

**WHEREAS**, the West Nassau High School Cheerleaders competed in the Division of Medium Varsity Non-Tumbling against twenty-eight teams in the preliminary round, earning first place and allowing them to bypass the semi-finals and securing their spot in the finals; and

**WHEREAS**, the West Nassau High School Cheerleaders competed against eight other teams in the finals and won first place, earning the title of National Champions; and

**WHEREAS**, the commentators noted that the West Nassau High School Cheerleaders' stunt levels surpassed most collegiate performances; and

**WHEREAS**, the Board of County Commissioners commends the West Nassau High School Cheerleaders for their hard work and dedication and congratulates them on their accomplishment of winning the title of National Champions.
