2. The Board acknowledges Janet Gill for her outstanding service to the Property Appraiser, as well as those who had the privilege to work with her.


3. The Board, on behalf of all citizens in Nassau County, extends their sincere appreciation to Janet Gill for all she has done to make this a great County.

4. The Board hereby extends their congratulations to Janet Gill on her retirement and expresses best wishes for continued success, happiness and health in the years to come.




