

RESOLUTION NO. 2018-08

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, HONORING WILLIAM F. FLYNN, JR. FOR HIS EFFORTS ON RAISING FUNDS FOR THE FERNANDINA BEACH LIBRARY EXPANSION.

WHEREAS, it is with great honor that Nassau County recognizes Mr. William F. Flynn Jr. for his decades long commitment and dedication to the Fernandina Beach Library expansion and renovation project; and

WHEREAS, as the principal goal of the Nassau County Public Library Advisory Board Chair, and the Fernandina Beach Library Working Group Chair, Mr. William F. Flynn, Jr. was to cause a study to enlarge and modernize the existing library facility so programs and services were in sync with the growing needs of the community it serves; and

WHEREAS, Mr. William F. Flynn, Jr.'s resolute and diligent efforts assisted in forming a partnership between the Nassau County Board of County Commissioners and the City of Fernandina Beach Commissioners, wherein County and City officials signed agreements, each committing \$600,000 to expansion and renovation project; and

WHEREAS, in addition to the \$1.2 million allocated by Nassau County and the City of Fernandina Beach, Mr. William F. Flynn, Jr., as Friends of the Fernandina Beach Library President, was instrumental in raising an additional \$1,230,000 in gifts and pledges. 




