## **RESOLUTION NO. 2019-** 131

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, CLOSING ORANGE AVENUE, SITUATED IN NASSAU COUNTY, FLORIDA, TO VEHICULAR TRAFFIC

WHEREAS, the Board of County Commissioners of Nassau County are the fee simple land owners of a portion of Orange Avenue east of State Road 200, situated in Nassau County, Florida, more specifically described on Exhibit "A" attached hereto, and;

**WHEREAS**, the Board of County Commissioners is authorized to adopt a resolution closing a road pursuant to Section 177.101, Florida Statutes; and

WHEREAS, the petition of the Board of County Commissioners was duly presented to the Board of County Commissioners at its regular meeting on July 22, 2019 in order to set a public hearing; and

**WHEREAS**, a public hearing was held on August 12, 2019 by the Board of County Commissioners of Nassau County, Florida; and

WHEREAS, notice was published in accordance with the requirements of Section 177.101(4), Florida Statutes; and

WHEREAS, a notice of intention to apply to the Board of County Commissioners to close a portion of Orange Avenue was duly published in a newspaper of general circulation in Nassau County, Florida, on July 31, 2019 and August 7, 2019; and

WHEREAS, the Board of County Commissioners, in accordance with Section 177.101(3), Florida Statutes, has determined that closing a portion of Orange Avenue to vehicular traffic, except for emergency vehicles, is in the best interest of the public welfare.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Nassau County, Florida, that:

- 1. Recitals. The above recitals are true and are incorporated as legislative findings.
- Closure. Upon request of the Board of County Commissioners, the Board finds that a portion
  of Orange Avenue east of State Road 200 in Nassau County, Florida is hereby closed to
  vehicular traffic, with the exception for emergency vehicles.

3. This Resolution shall be spread upon the minutes of the Board of County Commissioners of Nassau County, Florida, and said Board of County Commissioners shall publish a notice of its adoption one (1) time within thirty (30) days hereafter in a newspaper of general circulation in Nassau County, Florida.




