

RESOLUTION 2020- 10

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, PURSUANT TO ORDINANCE NO. 99-02, AS AMENDED, AMENDING RESOLUTION NO. 2002-192, AS AMENDED BY 2003-34, AS AMENDED BY 2005-67, AS AMENDED, THAT INDICATES THOSE ORDINANCES THAT THE CODE ENFORCEMENT BOARD HAS AUTHORITY TO HOLD HEARINGS ON AND IMPOSE FINES FOR VIOLATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Ordinance No. 99-02, Section 8, the Chairman of the Code Enforcement Board shall indicate to the Board of County Commissioners the ordinances that the Code Enforcement Board requests authority to hold hearings and impose fines.


NOW, THEREFORE, BE IT RESOLVED this 27th day of January, 2020, by the Board of County Commissioners of Nassau County, Florida, that Resolution No. 2005-67, which amended 2003-34, which amended 2002-192, as amended, shall be further amended as follows:

1. The Code Enforcement Board shall hold hearings and impose fines against violators of the following ordinances and Codes:
 - a. Ordinance 2003-42 regarding beach concessions.
 - b. Ordinance 2004-58, as amended, regarding animal control.
 - c. Ordinance 97-19, as amended, the Zoning Code.
 - d. Ordinance 99-17, as amended, regarding roads and drainage.
 - e. Ordinance 97-14, as amended, regarding rights-of-way.
 - f. Ordinance 89-10, as amended, known as the "Nuisance Ordinance".
 - g. Ordinance 89-1, as amended, regarding signage for the unincorporated areas of Amelia Island, Florida.

- h. Ordinance 2002-29, as amended, known as the "off Island Unincorporated Area Billboard Ordinance".
 - i. All building code ordinances adopted by the Board of County Commissioners applicable to building inspectors only.
 - j. All fire protection and prevention codes adopted by the Board of County Commissioners. Said codes shall be enforced by the Fire Safety Inspector.
 - k. Ordinance No. 2005-10, which established Licensing Requirements and Regulations for Sexually Oriented Businesses in Nassau County.
 - l. **2020-06**
Ordinance No. _____, which prohibits simulated gambling devices.
2. The Fire Safety Inspector is hereby appointed as a Code Enforcement Officer to enforce any and all fire code ordinances and safety regulations contained within those ordinances or referenced in the fire safety codes.
 3. Animal Control officers are hereby designated to issue citations relating to animal control or cruelty to animals.
 4. This Resolution shall become effective upon its being executed by the Chairman of the Board of County Commissioners.
