County Commissioners of Nassau County, Florida; and

WHEREAS, as a result of COVID-19, the County continues to address situations within the

County, and there exists a need to extend this local State of Emergency to facilitate measures to protect

citizens, visitors and property.

County, Florida, this 30th day of November, 2020 as follows:

Local Emergency for an additional seven-day period from December 2, 2020 through December 9, 2020

due to on-going situations associated with COVID-19 in areas within the county.
