County, and there exists a need to extend this local State of Emergency to facilitate measures to protect

citizens, visitors and property.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Nassau

County, Florida, this 22nd day of February, 2021 as follows:

Local Emergency for an additional seven-day period from February 22, 2021 through March 1, 2021 due

to on-going situations associated with COVID-19 in areas within the county.
