County, and there exists a need to extend this local State of Emergency to facilitate measures to protect

citizens, visitors and property.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Nassau

County, Florida, this 15<sup>th</sup> day of March, 2021 as follows:

Local Emergency for an additional seven-day period from March 15, 2021 through March 22, 2021 due to

on-going situations associated with COVID-19 in areas within the county.
