County, and there exists a need to extend this local State of Emergency to facilitate measures to protect

citizens, visitors and property.

County, Florida, this 29th day of March, 2021 as follows:

Local Emergency for an additional seven-day period from March 29, 2021 through April 5, 2021 due to

on-going situations associated with COVID-19 in areas within the county.
