WHEREAS, Janet Wylie, announced her retirement effective April 1, 2022; and


WHEREAS, Janet Wylie will be greatly missed by those who had the pleasure to work with her, as well as the citizens of Nassau County.

NOW, THEREFORE, BE IT RESOLVED this 11th day of April, 2022,


