**WHEREAS**, Keith Kirkland, in all his endeavors, was a great asset to the Property Appraiser's Office and County; and


**WHEREAS**, Keith Kirkland announced his retirement effective September 30, 2022; and

**WHEREAS**, Keith Kirkland will be greatly missed by those who had the honor to work with him, as well as the citizens of Nassau County.



- 4. The Board hereby extends their congratulations to Keith Kirkland on his retirement and expresses best wishes for continued success, happiness, and health in the years to come.


