**WHEREAS**, Tammy Conley will be greatly missed by those who had the pleasure


to work with her, as well as the citizens of Nassau County.

**NOW, THEREFORE, BE IT RESOLVED** this 19th day of October, 2022,



3. The Board hereby expresses best wishes to Tammy Conley for continued health and happiness in the years to come.


