WHEREAS, Jamie Vendola, in all her endeavors, was a great asset to the Property Appraiser's Office and County; and


WHEREAS, Jamie Vendola announced her retirement effective February 28, 2023; and

NOW, THEREFORE, BE IT RESOLVED, this 15th day of February 2023, by the Board of County Commissioners of Nassau County, Florida as follows:


1. The Board publicly commends Jamie Vendola for her outstanding service and dedication to the citizens of Nassau County.


