RESOLUTION NO. 2023-149

A RESOLUTION AMENDING RESOLUTION NO. 2017-99, WHICH NAMED THE MEMBERS OF THE NASSAU COUNTY ESSENTIAL HOUSING ADVISORY COMMITTEE, TO ADD NEW MEMBERS AND REAPPOINT CURRENT MEMBERS OF THE COMMITTEE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Resolution No. 2017-99 on May 17, 2017, which named the members of the Nassau County Affordable Housing Advisory Committee and Resolution No. 2018-59 which replaced one member of the Committee; and

WHEREAS, on May 15, 2019, the members of the Affordable Housing Advisory Committee elected to rename the Committee the "Essential Housing Advisory Committee," in recognition that their work encompasses a spectrum of housing issues and directly relates to the essential nature of housing in providing for residents' health and well-being; and

WHEREAS, on October 1, 2020, the Florida Legislature amended Section 420.9076(2) F.S. to add one locally elected official from each county or municipality participating in the State Housing Initiatives Partnership Program to the categories constituting representation of the Affordable Housing Advisory Committee; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Resolution No. 2021-161 on August 18, 2021, which reappointed members for another two-year term and appointed two new members to fill vacant positions; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Resolution No. 2022-143 on July 11, 2022, which appointed four new members to fill vacant positions for a two-year term; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Resolution No. 2023-24 on April 19, 2023, which appointed two new members to fill

vacancies through August 31, 2023, and for a two-year term effective September 1, 2023 through August 31, 2025; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, adopted Resolution No. 2023-123 on June 26, 2023, which appointed one new member to fill vacancies through August 31, 2023, and for a two-year term effective September 1, 2023 through August 31, 2025; and

WHEREAS, one member of the Committee resigned and needs to be replaced, filling the role of a citizen who is actively engaged as a not-for-profit provider of affordable housing; and

WHEREAS, four members have reached the end of their two-year term and wish to be reappointed for another term.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida as follows:

- 1. The following member is appointed to a two-year term, effective August 28, 2023 through August 31, 2025: Carol Bolton.
- The following members are reappointed to a two-year term, effective September 1,
 2023 through August 31, 2025: Greg Matovina, Barbara McDuffie, Kathy Burns Alt:
 Tia Brown, and Jenna Emmons.
- The members of the Essential Housing Advisory Committee shall be those individuals as set forth in the attached amended Exhibit "A".
- All other provisions of Resolution No. 2017-99 not in conflict shall remain in full force and effect.

EXHIBIT "A"

AFFORDABLE HOUSING ADVISORY COMMITTEE SELECTION CRITERIA IN ACCORDANCE WITH FLORIDA STATUTES 420.9076: The Affordable Housing Advisory Committee shall be comprised of at least eight but not more than eleven members, who shall perform the duties as described in Section 420.9076, Florida Statutes. The Affordable Housing Advisory Committee shall consist of one representative from at least six of the categories set forth below and at least one locally elected official pursuant to Section 420.9076(2).
