

RESOLUTION 2024- 039

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, RESCINDING THE PREVIOUSLY ADOPTED RESOLUTION 2010-161 DESIGNATING THE FERNANDINA BEACH ARTS COUNCIL AS THE COUNTY-WIDE ARTS COUNCIL FOR NASSAU COUNTY; PROVIDING FOR FINDINGS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 25, 2010, the Nassau County Board of County Commissioners adopted Resolution 2010-161 designating the Fernandina Beach Arts Council as the County-Wide Arts Council for Nassau County in order to pursue grant opportunities to finance art related programming, facilities and awareness in Nassau County; and

WHEREAS, on March 19, 2024, the City of Fernandina Beach adopted Resolution 2024-48 approving the sunset of the Fernandina Beach Arts Council a/k/a Arts and Culture Nassau; and

WHEREAS, the City of Fernandina Beach has made Nassau County aware of the desire of the City Commission of Fernandina Beach to permanently sunset the Fernandina Beach Arts Council a/k/a Arts and Culture Nassau; and

WHEREAS, the Nassau County Board of County Commissioners further finds that it is in the best interests of the County and its citizens to rescind the previously adopted Resolution 2010-161 and further revokes the designation of the Fernandina Beach Arts Council, a/k/a Arts and Culture Nassau, as the County-Wide Arts Council for Nassau County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, as follows:

SECTION 1. FINDINGS.

The above findings are true and correct and are hereby incorporated herein by reference.

SECTION 2. RECISSION OF RESOLUTION 2010-161.



This Resolution shall take effect immediately upon its passage.




