

RESOLUTION 2025- 133

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF NASSAU COUNTY, FLORIDA, AMENDING RESOLUTION 2019-
163; PROVIDING FOR FINDINGS; PROVIDING FOR REMOVAL OF
THE ‘NO THRU TRUCKS’ AND ‘LOCAL DELIVERIES ONLY’
SIGNS FROM DYAL ROAD FROM US 1 TO CR 115; PROVIDING AN
EFFECTIVE DATE.**

WHEREAS, on October 28, 2019, the Board of County Commissioners of Nassau County, Florida approved Resolution 2019-163 prohibiting through truck traffic on Dyal Road and Pratt Siding Road from US 1 to CR 115 and authorizing the placement of “NO THRU TRUCKS” and “LOCAL DELIVERIES ONLY” signs on the sections of Dyal Road and Pratt Siding Road from US 1 to CR 115; and

WHEREAS, at the time Resolution 2019-163 was approved by the Board of County Commissioners, a portion of Dyal Road was unpaved and lacked the proper structure to accommodate unnecessary truck and thru traffic; and

WHEREAS, since approval of Resolution 2019-163, the County has paved the previously unpaved portions of Dyal Road providing the proper structure to accommodate additional truck and thru traffic; and

WHEREAS, the “NO THRU TRUCKS” and “LOCAL DELIVERIES ONLY” signs are no longer needed to prohibit truck and thru traffic on Dyal Road from US 1 to CR 115; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida finds it in the best interest of the County and its citizens to amend Resolution 2019-163 to remove the reference to Dyal Road and authorize the removal of the “NO THRU TRUCKS” and “LOCAL DELIVERIES ONLY” signs on Dyal Road from US 1 to CR 115.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, as follows:

SECTION 1. FINDINGS.

The above findings are true and correct and are hereby incorporated herein by reference.

SECTION 2. AMENDING RESOLUTION 2019-163.

Resolution 2019-163 is hereby amended to remove the reference to Dyal Road.

SECTION 3. REMOVAL OF "NO THRU TRUCK" AND "LOCAL DELIVERIES ONLY" SIGNS.






