A RESOLUTION UPDATING THE PURCHASING POLICY SIGNATURE AUTHORITIES FOR THE BOARD OF COUNTY COMMISSIONERS; PROVIDING

AN EFFECTIVE DATE

WHEREAS, on April 13, 2009, the Board of County Commissioners adopted a Purchasing

Policy, as amended, which governs the County's purchases of goods and services in order to

provide a systematic approach to the process of buying required goods and services in proper

quantities and qualities, from the right sources at the right times, and at fair prices; and

WHEREAS, the Board of County Commissioners has previously authorized personnel to

approve invoices, requisitions and budget transfers through separate actions of the Board as part

of individual Finance Packages; and

WHEREAS, the Board of County Commissioners previously adopted Resolution 2025-79

updating the purchasing policy signature authorities; and

WHEREAS, the County's Purchasing Policy currently requires signature authority for

contracts, change orders, task orders, work authorizations, and amendments to be set by resolution;

and

WHEREAS, the proposed signature authorities are provided as Exhibit "A" to this

Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners,

Nassau County, Florida in regular session duly assembled on the 25th day of August 2025,

that Resolution 2025-79 shall be rescinded in its entirety and the signature authorities attached

hereto as Exhibit "A" be effective upon adoption.
