LEASE AGREEMENT

THIS AGREEMENT, Made and Entered into this 30th day of November, A. said equipment having been delivered to the Lessee at Hilliard, Florida, on or about November 30, 1971.

1. The Lessee hereby acknowledges receipt of said equipment in good condition and for the use thereof for said term, stipulates and agrees to pay to the Lessor as rental thereof, the sum of \$23,641.00, to be paid to the Lessor, without interest, in Two (2) equal payments of \$11,820.50 each, with the first payment commencing on the 30th day of March, 1972, and the final payment due and payable the 30th day of March 1973. The above specified rental in the sum of \$23,641.00 based on the rental of One (1) New Galion T-500A Motor Grader. 2.
