THIS AGREEMENT entered into this day of March, 1980, by and between DR. FARID ULLAH of Fernandina Beach, Florida, hereinafter referred to as "ULLAH", and NASSAU COUNTY, a governmental subdivision of the State of Florida, hereinafter referred to as "COUNTY", who for and in consideration of the compensations, services and other good and valuable considerations agree as follows:

1. COUNTY shall insure ULLAH for any actions he may be required to perform as Emergency Medical Services Director of Nassau County, and shall be insured under the insurance program of Nassau County.

2. ULLAH shall serve as Director of Emergency Medical Services for Nassau County and as such he shall be responsible for the following:

- Supervising the qualifications of volunteers, employees and any others involved in emergency rescue programs.
- Recommending dismissal of any persons who are not able to comply with qualifications and standards as promulgated by state law and Nassau County Emergency Medical Committee Standards.
- 3.) Supervise continuing medical educational programs and seminars.
- Supply medical advice to emergency medical technicians and paramedics where feasible and possible.

3. ULLAH shall be compensated at the rate of FIVE HUNDRED DOLLARS (\$500.00) per month for the period of one year with option by both parties to renew under mutual agreement upon terms.

4. This Agreement may be canceled by written notice by one party to another at their normal mailing address notifying said party of termination at the end of thirty (30) days from the receipt of said notice.

5. This Agreement may be amended by mutual written agreement signed by both parties hereto.
