Dear Mr. Mullin:

I was pleased to meet with you last week to discuss Nassau County's concerns for preparing a Comprehensive Plan which satisfies the requirements of Florida law while appropriately considering the issues of concern with the County government. As I stated at our meeting, my experience as Planning Director in Lake and Charlotte Counties has made me acutely aware of the problems that a county government faces when trying to meet the requirements of 9J-5, F.A.C., and 163.3, F.S.

Based upon my experience as a county planning director and the insight we have all gained at the RPC regarding DCA's comprehensive plan review policies, I believe that the RPC staff can revise the Nassau County Comprehensive Plan to make it meet the requirements of Florida law and be reasonably acceptable to Nassau County citizens and the Board of County Commissioners.

Attached is the proposed "Statement of Work" with associated manhours and cost estimate that was promised during our meeting. This cost is based upon the Nassau County Board of Commissioners agreeing to the adoption of a Plan which the RPC represents as meeting the requirements of Chapter 163, F.S., and Rule 9J-5, F.A.C., and standing a reasonable chance of satisfying DCA's "Objections, Recommendations, and Comments." Should the Plan require a major revision following a DCA "Letter of Intent" because of items omitted or submitted against the recommendation of the RPC staff, these revisions will increase the cost estimate of Phase II, "Response to Letter of Intent." The RPC feels confident that this is an accurate estimate of the true cost to complete this project; however, to protect both the County and the RPC, we propose that the project be conducted on a time and materials basis.

The RPC accepts the responsibility to support its member Counties in developing workable comprehensive plans that will guide the future development of the northeast Florida region. A very important component of the Comprehensive Planning effort is the development of Land Development Regulations that implement the Plan. Therefore, this offer of the RPC to complete the Nassau County Comprehensive Plan is contingent upon Nassau County's contracting with the RPC to develop the County's LDRs, as well as the Comprehensive Plan. The total cost proposed by the RPC for preparing the LDRs should be reimbursed to Nassau County through DCA grants.

Once Nasasu County has adopted its Comprehensive Plan, it must implement a procedure or system for managing concurrency. The Land Development Regulations package will include an ordinance which establishes the basic parameters of such a procedure; however, Nassau County will be required to prepare a "Methods and Procedures Manual" for implementing concurrency management within the County.
