
ATR will accept waste tires from Nassau County and recycle these to end products recognized by the FDEP as a recycled use.

Option 1: ATR will spot a 45 foot trailer at the landfill, for loading by the landfill, and transport the filled trailer to ATR for the price of \$0950.00 per trailer. (which is \$84 per ton full trailer).

Option 2: ATR will accept tires from Nassau County Solid Waste at the ATR dock for the price of \$065.00 per ton, based on the county weight ticket.

ATR does not accept air plane, OTR tires or material contaminated by dirt or waste. Nassau County agrees to pay ATR for services within 30 days and provide empty and full weight tickets for billing purposes.

This agreement is the first year renewal option of three one year renewals. ATR has enjoyed working with the staff representing the County and hope too continue our relationship.

Dear Sirs:

Per our proposal of August 17, 1995, *American Tire Recyclers (ATR)* contracts to accept and transport Waste Tires from Nassau County Solid Waste to *ATR's* Jacksonville plant and process the tires into marketable products.

1. The cost to Nassau County is \$84.00 per ton for all passenger and truck tires and \$150.00 per ton for agricultural tires.
2. Tires must be clean, i.e., not tires that have been in a landfill or covered or filled with dirt or rocks. These tire will be accepted **with** an additional charge of \$2.50 per tire.
3. *ATR* will furnish trailers for on-site loading of tires.
4. Nassau County will load trailers and provide weight tickets- both full and empty.
5. Payment must be received within 30 days of invoice date.

This contract will remain in effect from date of award through August 30, 1996 with the option to renew for three (3) additional one (1) year periods.
