SECOND AMENDMENT TO THE AGREEMENT FOR WEBSITE DEVELOPMENT SERVICES FOR NASSAU COUNTY, FLORIDA

WHEREAS, on May 14, 2010, Article 5.2.1 was amended to include an additional fee for the support and hosting of a sub-site for the Library, which is a distinct piece of the primary website. Article 5.2.1 now reads: The County shall pay to the Consultant a Recurring Annual Hosting Fee in the amount of \$3,000.00 \$4,200.00; and

WHEREAS, the original agreement provided for an initial term beginning November 19, 2008 and ending November 18, 2011, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

 In accordance with Section 4 of the Agreement dated November 19, 2008, the performance period is hereby extended for an additional one (1) year beginning November 19, 2011 and ending November 18, 2012. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
