## AMENDMENT NUMBER 3 /THIRD EXTENSION TO THE AGREEMENT FOR PUBLIC RELATIONS

- 1. In accordance with Section 3.5 of the Agreement for Public Relations dated September 24, 2007, this agreement is amended to hereby extend the performance period for an additional two years, beginning October 1, 2010 and ending September 30, 2012.
- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
