AMENDMENT NO. 2 / FIRST EXTENSION TO THE AGREEMENT FOR TOTAL LEACHATE MANAGEMENT

WHEREAS, Amendment No. 1 was executed by both parties on July 17, 2013 amending the term to begin August 1, 2013 and end September 30, 2015; and

WHEREAS, the parties desire to amend and extend said Agreement.
