## ADDENDUM NO. 13/12<sup>TH</sup> EXTENSION TO THE AGREEMENT FOR LOBBYIST SERVICES

THIS ADDENDUM entered into this 10th day of August , 2015 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and MARK ANDERSON, 106 S. Monroe Street, Tallahassee, Florida, 32301, (hereinafter referred to as "Anderson").

WHEREAS, the parties entered into an Agreement dated January 13, 2003; and

WHEREAS, the original agreement provided for an initial term beginning January 20, 2003 and ending January 20, 2004, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties agreed to initially extend the agreement for the remainder of the fiscal year ending September 30, 2004; and then for successive one year periods commencing October 1, 2004 and ending September 30, 2013;

WHEREAS, the parties agreed to extend the agreement for a two (2) year period commencing October 1, 2013 and ending September 30, 2015;

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 13 of the Agreement dated January 13, 2003, the performance period is hereby extended for two (2) three (3) additional years beginning October 1, 2015 and ending September 30, 2018.
- 2. All other provisions of said Agreement and subsequent amendments not in conflict with this Addendum shall remain in full force and effect.
