EXHIBIT A

SCOPE OF SERVICES

CLARIFIER NO. 1 AND NO. 2 REHABILITATION NASSAU COUNTY, FLORIDA

I. BACKGROUND

NAU's Capital Improvement Program fiscal year (FY) 2016-2017 has identified the following projects:

- Clarifier No. 1 Rehabilitation (West of Aerator Tanks and manufactured by Kusters Water)
- Clarifier No. 2 Rehabilitation (North of Aerator Tanks and manufactured by EIMCO)

These projects are necessary to continue meeting NAU's level of service. The listed infrastructures have exceeded their design life cycles. Visual inspections of these infrastructures showed high level of deterioration caused by the exposure to hydrogen sulfide over the years.

II. SCOPE OF SERVICES

The scope of services will be managed and develop in the following tasks:

Task 1 - Project Management

- Kick-off Meeting: GAI will meet with NAU key personnel to introduce project team, define the project communication protocol, and review scope of service and project expectations. GAI will prepare meeting minutes.
- 2. Progress Meetings: GAI will host up to three review or progress meeting at the County or at GAI facilities.

Task 2 - Data Collection/Assessment

- 1. GAI will use and study the record drawings title "0.25 MGD Wastewater Treatment Plant Expansion to Existing 0.6 MGD Plant" to create new construction plans for Clarifier No. 1 and "Sewage Treatment Plant" to create new construction plans for Clarifier No. 2.
- 2. GAI's project manager and structural engineer will visit the site and take pictures of the structure to be included in the bid documents.
- 3. GAI will survey the structure:
 - 3.1. GAI will complete the topographic to prepare survey base mapping for the structure.
 - 3.2. All evident planimetric and topographic features will be surveyed and mapped.
 - 3.3. Underground utilities will be shown to the extent possible based on surface evidence, maps of record and vertical surveying.
 - 3.4. Mapping will be provided at an appropriate scale for design and will be completed in AutoCAD Civil 3D.

 - 1.2. Create site plans including yard piping
- Structural Engineering Services
 - 2.1. Create necessary details to support the concrete rehabilitation technical specifications.

- 2.2. Develop technical specification for structural rehabilitation requirements and coating.
- 3. Process Engineering Services
 - 3.1. Prepared demolition plans.
 - 3.2. Specify a clarifier identical to the existing clarifier. Specification will be written around KRUSTER and OVIVO (fka EIMCO). GAI will consider one more manufacturer Westech.
 - 3.3. Design and specify provisions to isolate each clarifier.

 - 4.1. Prepared demolition plans.
 - 4.2. Design and specify the power, signal, lighting and grounding.
- 5. Instrumentation Engineering Services

 - Technical Specifications for clarifier with three manufactures and concrete rehab/coating.

 - Clarifier Bypass Plan
 - Details
- 7. Prepare and submit FDEP notification letter.
- 8. Prepare Opinion of Probable Construction Cost (OPC).
- 9. Meet (progress meeting) with the County to review 60% submittal.
- 10. Incorporate the County's 60% submittal comments.
