AMENDMENT NO. 1 / FIRST EXTENSION TO THE
AGREEMENT FOR PART-TIME CONTRACT WORK

THIS ADDENDUM entered into this _____ day of _____, 2017 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and CHARLOTTE J. YOUNG, (hereinafter referred to as "Young").

WHEREAS, the parties entered into an Agreement dated April 17, 2017; and

WHEREAS, the original agreement provided for an initial term of ninety (90) days beginning April 17, 2017 and ending July 15, 2017, with an option to extend for ninety (90) day periods upon execution of extension, by both parties.


WHEREAS, the parties desire to amend and extend said Agreement.


