**AMENDMENT NO. 1/FIRST EXTENSION TO THE  
AGREEMENT FOR GARBAGE DISPOSAL SERVICE**

THIS ADDENDUM entered into this 22 day of August, 2017 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **ADVANCED DISPOSAL STATELINE 450496 S.R. 200 Callahan, Fl. 32011**. (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated October 1, 2016; and

**WHEREAS**, the agreement allows for a one (1) year extension under Section 20 upon mutual agreement of both parties; and


**WHEREAS**, the parties desire to amend and extend said Agreement.
