**AMENDMENT NO. 1 TO THE
AGREEMENT FOR UNIFORM SHIRT RENTAL**

THIS ADDENDUM entered into this 14th day of March, 2018 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and Unifirst Corporation, located at 1446 Haines Street, Jacksonville, Fl. 32206 (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated November 13, 2017 for uniform shirt rental services; and

WHEREAS, the technical specifications/scope of work in the original agreement allows for these services to be offered to other departments within the County; and

WHEREAS, the Solid Waste Department desires to have uniform rental services provided under this agreement; including services for the rental of floor mats; and

WHEREAS, the parties desire to amend said Agreement.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. Vendor shall provide customer service to the Solid Waste Department for the rental and service of uniform shirts and mats as follows:

4	Rental of 10 "other" Long Sleeve Shirts	\$2.10
	3x10 Mat	\$5.00

2. The performance period for this amendment shall begin January 24, 2018 and shall extend through the end of the original term ending September 30, 2019. Any extension of performance period shall be in accordance with the terms of the agreement.
3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
