**AMENDMENT NO. 02 / FIRST EXTENSION TO THE
AGREEMENT FOR EQUIPMENT RENTAL SERVICES**

THIS ADDENDUM entered into this 30th day of October, 2017 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Herc Rentals Inc.** located at Post Office Box 26360 Oklahoma City, Oklahoma 73126-0360 (hereinafter referred to as "Contractor").

WHEREAS, the parties entered into an Agreement dated September 28, 2015; and

WHEREAS, the original agreement provided for an initial term of two (2) years beginning October 1, 2015 and ending September 30, 2017, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


