**AMENDMENT NUMBER 9/NINTH EXTENSION TO THE  
CUSTODIAL SERVICES AGREEMENT**

THIS AMENDMENT entered into this 20<sup>th</sup> day of June, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as the "County") and EVELYN JONES, 1748 Julia Street, American Beach, Florida, 32034, (hereinafter referred to as "Independent Contractor").

**WHEREAS**, the parties entered into an Agreement dated April 12, 2010, for Custodial Services for American Beach Community Center; and

**WHEREAS**, the original Agreement provided for an initial performance period beginning April 12, 2010 and ending April 11, 2011 and provided for one (1) year renewals upon mutual agreement of the parties; and


**WHEREAS**, the original Agreement was extended for the subsequent annual periods beginning April 12, 2011 and ending April 11, 2019; and

**WHEREAS**, the parties desire to extend the original Agreement once again for one (1) year beginning April 12, 2019 and ending April 11, 2020.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 3 of the original Agreement dated April 12, 2010, the performance period is hereby extended for an additional one (1) year beginning April 12, 2019 and ending April 11, 2020.
2. All other provisions of the original Agreement not in conflict with this Amendment shall remain in full force and effect.
