We had our first price increase 1/1/2016 in 7 years. An email went out to all maintenance customers letting them know about the increase, but that the increase would not affect renewals until 2017. There were two major parts to the increase. First was a substantial rise in the cost of parts if a repair is needed. Second is the sustaining engineering needed to keep older units viable as components of the hardware become obsolete. Just to look at one part, the mainboard in the FMU had gotten to a level where retail on that part alone was more than the cost of maintenance at old pricing. I hope this explains the increase, and we hope to maintain this pricing as we did in the past.
