



**AMENDMENT NUMBER TWO/SECOND EXTENSION TO THE  
CUSTODIAL SERVICES AGREEMENT**

THIS ADDENDUM entered into this 28th day of November, 2018 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **MICHAEL FAVORS**, 58871 Coopers Neck Road, Hilliard, FL 32046, (hereinafter referred to as "Independent Contractor").

**WHEREAS**, the parties entered into an Agreement dated December 6, 2016, for Custodial Services for Callahan Multi-Use Facility; and

**WHEREAS**, the original agreement provided for an initial term of December 1, 2016 through November 30, 2017 and provided for one year renewals upon mutual agreement of the parties; and


**WHEREAS**, the parties desire to extend said Agreement.

2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.


