AMENDMENT NO. 2 / SECOND EXTENSION TO THE
CONTRACT FOR LIMEROCK MATERIAL

THIS AMENDMENT entered into this 13th day of September, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and BEAVER BULK, INC., whose principal address is 10264 US Hwy 129, Live Oak, Florida 32060, and whose mailing address is P.O. Box 417, Live Oak, Florida 32064, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a Contract for Limerock Material (hereinafter referred to as "Contract") on or about July 15, 2015; and

WHEREAS, the Contract provided for an initial term of three (3) years beginning August 12, 2015 and ending September 30, 2018 with an option of one (1) year extensions based on the best interest and sole discretion of the County; and


WHEREAS, the parties extended the Contract for a period of one (1) year beginning October 1, 2018 and ending September 30, 2019; and

WHEREAS, the parties desire to extend the Contract for a period of one (1) year beginning October 1, 2019 and ending September 30, 2020.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 20 of the *Contract*, the performance period is hereby extended for an additional one (1) year beginning October 1, 2019 and ending September 30, 2020.
2. All other provisions of said *Contract* not in conflict with this Amendment shall remain in full force and effect.
3. Time is of the essence.


