**AMENDMENT NO. 02/FIRST EXTENSION TO THE
CONTRACT FOR GENERATOR ANNUAL MAINTENANCE**

THIS AMENDMENT entered into this 30th day of October, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and Zabatt Power Systems, located at 4612 Highway Avenue, Jacksonville, FL 32254, hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Generator Annual Maintenance* (hereinafter referred to as "Contract") on or about September 13, 2016; and

WHEREAS, the *Contract* provided for an initial term beginning October 1, 2016 and terminating September 30, 2019, with an option to extend in one (1) year increments upon mutual contract between the Vendor and the County; and

WHEREAS, the parties desire to extend the *Contract*.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

one (1) year beginning October 1, 2019 and terminating September 30, 2020.


2. All other provisions of the *Contract* not in conflict with this Amendment shall remain in full force and effect.
