AMENDMENT NO. 5 / FIFTH EXTENSION TO THE
LEASE AGREEMENT FOR THE
NASSAU OAKS VOLUNTEER FIRE DEPARTMENT

THIS AMENDMENT entered into this 5th day of November, 2019 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **NASSAU OAKS VOLUNTEER FIRE DEPARTMENT**, 56300 Nassau Oaks Drive, Callahan, Florida 32011, (hereinafter referred to as "Nassau Oaks").

WHEREAS, the parties entered into an Agreement dated November 26, 2014; and

WHEREAS, the Agreement provided for an initial term of one (1) year beginning October 1, 2014 and ending September 30, 2015, with an option to extend upon mutual agreement between the parties; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties agreed to extend the Agreement for the period beginning October 1, 2015 and ending September 30, 2019; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Article 2 of the Agreement for the Nassau Oaks Volunteer Fire Department dated November 26, 2014, the performance period is hereby extended for an additional one (1) year beginning October 1, 2019 and ending September 30, 2020.
2. All other provisions of said Agreement not in conflict with this Agreement shall remain in full force and effect.


