AMENDMENT NO. 1 / FIRST EXTENSION TO THE

WHEREAS, the original Agreement provided for an initial term beginning October 10, 2018 and ending September 30, 2019; and


WHEREAS, the parties desire to amend and extend said Agreement for (3) three months beginning October 1, 2019 and ending December 31, 2019.

1. Extend the Agreement for professional magistrate services for an additional (3) three months beginning October 1, 2019 and ending December 31, 2019.


2. All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.


