**AMENDMENT NO. 3 / THIRD EXTENSION TO THE**  
**AGREEMENT FOR PROFESSIONAL DESIGN SERVICES FOR THE**

**WHEREAS**, the parties extended the Agreement through May 21, 2020; and


**WHEREAS**, the parties amended and extended said Agreement for a second time beginning May 22, 2020 and ending September 30, 2020; and
