


**FIRST AMENDMENT TO EXTEND THE CONTRACT FOR LIQUID SODIUM  
HYPOCHLORITE FOR NASSAU AMELIA UTILITIES**

THIS AMENDMENT made and entered into this 2nd day of September, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as the "County", and **ALLIED UNIVERSAL CORPORATION**, 3901 Northwest 115<sup>th</sup> Avenue, Miami, Florida 33178, hereinafter referred to as the "Vendor".

**WHEREAS**, the County entered into a Contract with the Vendor on September 25, 2017 for the supply of liquid sodium hypochlorite to Nassau Amelia Utilities; and


**WHEREAS**, the Contract provided for an initial term beginning October 1, 2017 and ending September 30, 2020, with an option to extend upon agreement between the parties; any extension of performance period under this provision shall be in one (1) year increments; and

**WHEREAS**, the parties desire to amend and extend the Contract for an additional one (1) year beginning October 1, 2020 and ending September 30, 2021; and

**NOW, THEREFORE**, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:


1. In accordance with Section 20, Period of Contract/Option to Extend or Renew, of the Contract dated September 25, 2017, the Contract is hereby extended for an additional one (1) year beginning October 1, 2020 and ending September 30, 2021.
2. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
