**AMENDMENT NO. 6 / SIXTH EXTENSION TO THE
RESERVE/SUPPORT AGREEMENT FOR THE NASSAU OAKS
VOLUNTEER FIRE DEPARTMENT**

THIS AMENDMENT entered into this 20th day of October, 2021 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as “County”) and **BOARD OF DIRECTOR OF NASSAU OAKS VOLUNTEER FIRE DEPARTMENT, 56300 Nassau Oaks Drive, Callahan, Florida 32011**, (hereinafter referred to as “Nassau Oaks”).

WHEREAS, the parties entered into an Agreement dated August 24, 2015; and


WHEREAS, the terms of the Agreement were extended on an annual basis beginning October 1, 2016 and ending September 30, 2021; and

WHEREAS, a recommendation by the Fire Chief is hereby made to the Board of County Commissioners to extend the terms of the Agreement for an additional one (1) year period beginning October 1, 2021 and ending September 30, 2022.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:






