This Work Authorization is to the AGREEMENT between Nassau County and the Consultant known as the Interlocal Agreement between Nassau County and Florida Governmental Utility Authority for Water and Wastewater Utility Capital Project and related Grant/Loan Administration and Special Assessment Services, dated December 12, 2019. The services to be provided under this Work Authorization are as follows:

ARTICLE 1. Services Described as:

The Consultant shall assist the County in carrying out all the remaining Engineering Services, Capital Project Administration, and Inspection services necessary during the construction phase of the Amelia Island WWTP Generator Replacement Project. These services shall include project management, review of technical submittals, preparation of meeting agendas and minutes, review of construction contractor payment applications, coordination with plant operations and field inspection services. The original work authorization for the referenced scope expired July 7, 2021. The current anticipated construction project completion is December 31st. The consultant work authorization included herein is for the remaining time and costs required to provide engineering services during construction, capital project administration and inspection services for the remaining construction contract scope.

ARTICLE 2. Time Schedule

The Consultant shall complete the Work within three (3) months of the Notice to Proceed being issued to the construction Contractor by the County.

ARTICLE 3. Budget

CM2786-WA05 (Amelia Island WWTP Generator Installation Engineering, Capital Administration, and Inspection Services) was approved on February 5, 2021 with a schedule budget of \$23,578.95. Invoices AI GRP-1 and GRP-2 inclusive of \$5,727.16 capital project administration have been submitted to and reimbursed by the County. The Consultant will perform the remaining Engineering and Capital Project Administration scope of services outlined herein for the lump sum amounts of \$10,400.00 and \$1,431.79, respectively. The remaining fee for Inspection Services is a not-to-exceed amount of \$6,020.00. The total remaining budget of \$17,851.79 from CM2786-WA05 will be effectively transferred to CM2786-WA13. Therefore, no additional funding is required to fund CM2786-WA13


Article 4. Other Provisions
